- Grant Corum provided information on the Capital Improvement Plan WWTP.01 and WWTP.06 with a cost of \$18,000. M. Bernius made a motion to approve the agreement with Farnsworth Group for construction engineering of the rake room project. (CIP – WWTP.01 & WWTP.06). J. Marner seconded. All Trustees voted YEA.
- Grant Corum provided information on two bids he received for an 800 amp manual transfer switch at the wastewater treatment facility. Grant's recommendation was to award the bid to Harris Electric. D. Tiffan made a motion to award the bid for an 800 amp manual transfer switch at the wastewater treatment facility to Harris Electric for \$17,595.00. J. Ray seconded. All Trustees voted YEA.
- President Randall provided information on two bids he received for attic insulation for the Community Building and Welcome Center. Pictures were provided of the areas that currently need attic insulation work. M. Bernius made a motion to accept the bid from Bernardi Construction for \$6,370.00 to be spent on the Community Building insulation and \$1,280.00 for the Welcome Center insulation. J. Ray seconded. All Trustees voted YEA.
- J. Ray made a motion to approve the purchase of a laptop computer from APTechnoligies in the amount of \$599.00. M. Bernius seconded. All Trustees voted YEA.
- Kenny Crossman provided information about changes to the sexual harassment policy, which includes increasing the time period to make a claim to 300 days. J. Ray made a motion to accept Ordinance 02-18A-2019: An Ordinance updating the Village's Sexual Harassment Policy. J. Marner seconded. All Trustees voted YEA.
