Consent Agenda

- 2. M. Hilgenberg made a motion to approve Resolution R-12-04A-2023: A resolution concerning the minutes of closed meetings and the destroying of tapes at least eighteen months old for meeting minutes which have been opened. C. Miller seconded. All Trustees voted YEA.
- 3. C. Miller made a motion to approve Resolution R-12-04B-2023: A resolution concerning tapes of closed meetings which have been opened. I. Guiterrez seconded. All Trustees voted YEA.
- 4. M. Bernius made a motion to approve Village employee end-of-year bonuses in the amount of \$300.00 for full-time employees and \$75.00 for part-time employees, with the Village paying the payroll taxes on the bonuses. J. Fleming seconded. All Trustees voted YEA.
